***STATE PENSIONS FORECASTING OPTION FORM  
FOR ELIGIBLE COUNCILLORS***

As a member of the Local Government Pension Scheme (the "LGPS") you will receive, each year from the County Council, a benefit statement setting out the value of your benefits under the Scheme.

Benefit statements will include information about your state pension entitlement as well as information about your benefits in the LGPS. In order to do this we need to get some information about you from the Department for Work and Pensions (the 'DWP'). To get the information we need first to tell the DWP the following about you:-

- surname
- forenames
- gender
- date of birth
- national insurance number
- payroll number

The DWP will then be able to tell us about:-

- the state pension you have earned so far
- what your state pension is likely to be when you retire
- the age from which you can receive your state pension

The information that we get from the DWP will be used only for the purposes of providing you with a forecast of your state pension rights.

If you object to us giving the DWP the above information about you then you should complete the details at the bottom of this form and return it to the address given below, as soon as possible. If you do this, your annual benefit statements will not include any information about your state pension.

If however you are happy for us to give the DWP the above information about you, you need do nothing. We shall then be allowed to disclose the above information about you to the DWP and to receive information from them, for as long as you continue to participate in the Powys Pension Fund.

If you do not now object to us giving the above information to the DWP, you may change your mind at any time in the future. If so, you should write to us at the address given below.
